But what exactly is this prescribed information? It seems apparent that most landlords don't know.

What information do landlords have to provide to tenants ...

Landlords can apply to the court for a possession order if the tenants do not leave by the date specified in the form as the earliest date on which possession proceedings can be brought.

A Private Residential Tenancy is open-ended and lasts until the tenant wishes to leave the property or the landlord uses one (or more) of the 18 grounds for eviction. A tenant can initiate ending a Private Residential Tenancy and are required to give the landlord at least 28 days prior written notice.
